Arrival with train:

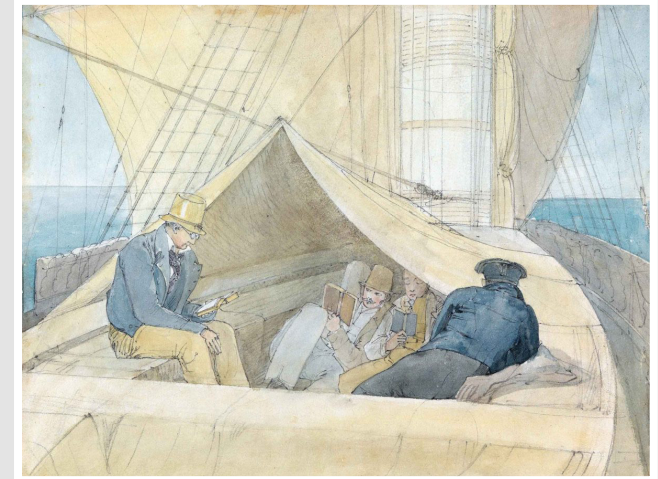
The town of Eichstätt is located between the two Bavarian cities of Munich and Nuremberg. It is connected to these cities by the railway line which spans from the town of Treuchtlingen all the way to the city of Ingolstadt. At the “Eichstätt Bahnhof” station, a further regional train line connects this outer station to the central station of the city of Eichstätt called “Eichstätt Stadt”. Please make sure to purchase the correct ticket, all the way to the central station located in the city center: Eichstätt Stadt. When arriving at Eichstätt Bahnhof, make sure to board the smaller train into the city center. Once there, the university and all of its facilities can be reached within 10 minutes of walking distance.

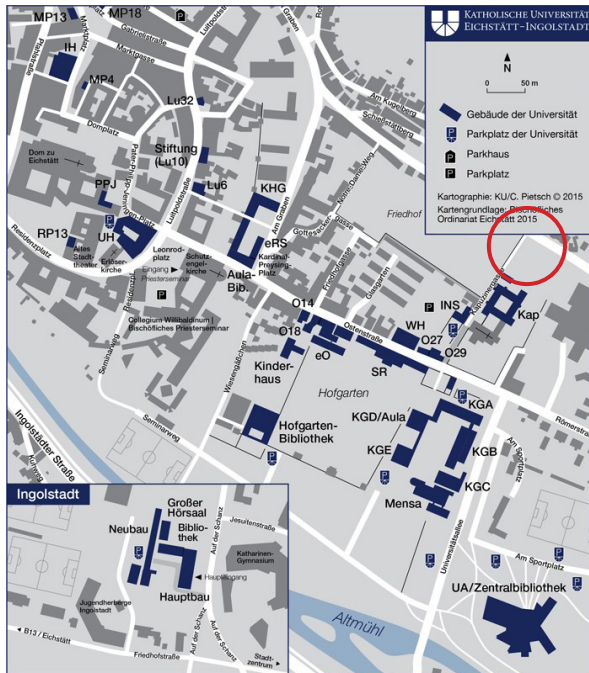
